# **Co-opted members:**

Co-opted members (x5)

The AGM or the Committee can co-opt up to five members to the Committee. Completing a nomination is the way to express an interest to be a co-opted member. These positions are **not** balloted. The AGM can choose to co-opt members or to defer this to the new Committee by way of majority votes. For example, filling the co-opted member vacancies may artificially increase the branch meeting quorum above 25 (see Rule 16) making the business of the Branch more difficult to complete. Additionally, any members who are elected to the UCU National Executive Committee are automatically Committee members which can further increase the number of members on Committee. Therefore, the AGM may decide to defer co-opting members for the new Committee to decide how best to proceed.

# **OTHER POSITIONS**

There are other opportunities for members to be elected to other positions that are not Committee positions (don't forget there are other non-elected ways to get involved too):

- **Congress Representatives (Rule 11)** these are elected annually from members of the Branch in the General Meeting every February/March and a calling notice is sent to all members in advance. Congress usually takes place in April/May and national conferences take place throughout the year. A pool will be elected, however the number of delegate positions will vary depending on the size of the Branch and the type of event.
- Members are also encouraged to stand for national UCU positions see the national UCU website for further information.
- Members are encouraged to get involved with the Branch, for example through Action Groups, campaigning, becoming a caseworker and becoming a Safety Rep.
