## 5. Any Other Business

**Personal casework training:** locally available training will be arranged in the near future and those interested were asked to indicate their willingness to get involved.

**Pay and job security:** Steve Collier responded to a question regarding the current state of the pay and job security dispute. It was noted that UCU will continue to press the employers for an improved package over the next few months. Any further ballot on industrial action to support this is likely to come in the Autumn now.

Liaison locally with other campus trades unions will continue to deal with the issues of job insecurity, increased number of restructures and rationalisation of departments/schools being experienced by members here at Sheffield.
